Each College/Institution/University shall send only one team.

REGISTRATION

The teams interested to participate are required to complete the registration formalities by filling up the Google forms by 12th February 2022 (11:59 p.m.). Scanned copy of Student's Institution Identity card should be uploaded while filling up the registration form.

The registration shall be deemed complete only when the registration fee has been remitted successfully and the registration form is duly filled.
