Against this backdrop, the conference seeks to examine how existing legal frameworks are holding up, where they are falling short, and what reforms are necessary.

The conference aspires to facilitate rigorous and forward-looking dialogue that bridges doctrinal analysis with policy relevance. By convening voices from across institutions, jurisdictions, and disciplines, it aims to contribute meaningfully to ongoing conversations in international legal scholarship and arbitration practice.

## ANNEXURE II - GUIDELINES FOR SUBMISSION OF ABSTRACTS

1. **Content of the Abstract:** Authors are required to submit a word document abstract containing details:
  - (a) Title of the Paper
  - (b) Author(s) Details i.e., Name / Institutional Affiliation / Designation / Email Address / Contact Number Abstract Body / Content Keywords
2. **Word Limit**
  - (a) The abstract shall be between 300–500 words, excluding title and keywords.
  - (b) Authors must provide 5 relevant keywords
3. **Formatting Guidelines for Abstracts**
  - (a) Font: Times New Roman
  - (b) Font Size: 12 pt
  - (c) Line Spacing: 1.5
  - (d) Alignment: Justified
  - (e) Margins: 1 inch on all sides
  - (f) File Format: Microsoft Word (.doc/.docx) The title of the abstract should be in Bold and Upper Case.
4. **Last Date to Submit Abstract - 15<sup>th</sup> September 2026**
5. **Abstract submissions shall be made through the Google Form.**

Authors whose abstracts are accepted shall submit full papers in accordance with the following guidelines:

**1. Presentation at the Conference shall be strictly subject to the submission of the Full Paper within the stipulated deadline. Failure to submit the Full Paper shall result in cancellation of participation, and the registration fee shall not be refunded.**

**2. Originality and Publication Ethics**

- (a) The full paper must be **original, unpublished & not under consideration** for publication/presentation elsewhere.
- (b) Any form of plagiarism, including self-plagiarism, shall result in immediate rejection.
- (c) Authors are expected to maintain high standards of academic integrity and ethical scholarship.

**3. Word Limit**

- (a) Full papers should ordinarily range between 4,000–8,000 words, excluding footnotes.
- (b) Exceptional papers exceeding the prescribed limit may be considered at the discretion of the Editorial Committee.

**4. Co-Authorship**

- (a) Co-authorship is permitted for a maximum of two authors.
- (b) Both authors, in case of co-authorship, must register separately for the conference.

**5. Plagiarism Policy**

- (a) Similarity index should preferably not exceed 10%, excluding references and commonly used legal terminology.
- (b) The Organizing Committee reserves the right to reject papers found to contain plagiarism or unethical academic practices.

- Authors are encouraged to prepare concise and engaging presentations highlighting the core arguments and findings of their papers.

9. Selected papers will be published in the form of an edited volume (peer - reviewed) with a Leading publisher.

## ANNEXURE V - HOW TO REACH HNLU RAIPUR?

HNLU is situated in the educational hub of **Nava Raipur - Atal Nagar, Raipur Chhattisgarh**, and is well connected by air, rail and road networks. Participants may reach the University through the following modes:



### BY AIR

The nearest airport is **Swami Vivekananda Airport**, located approximately 10–12 km from the University campus. Regular flights connect Raipur with major Indian cities, including Delhi, Mumbai, Bengaluru, Hyderabad, Kolkata and Chennai. Taxis and app-based cab services are readily available from the airport to the University campus.



### BY RAIL

The nearest major railway station is **Raipur Junction Railway Station**, situated approximately 20–22 km from HNLU. Raipur Junction is well connected to major cities across India through regular express and superfast train services. Participants may avail taxis, auto-rickshaws or app-based cab facilities from the railway station.



### BY ROAD

HNLU is accessible through a well-developed road network connecting Raipur city and Atal Nagar (Naya Raipur). Regular taxi, bus and app-based transport services are available from different parts of Raipur city to the University campus.

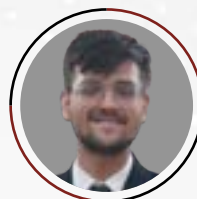

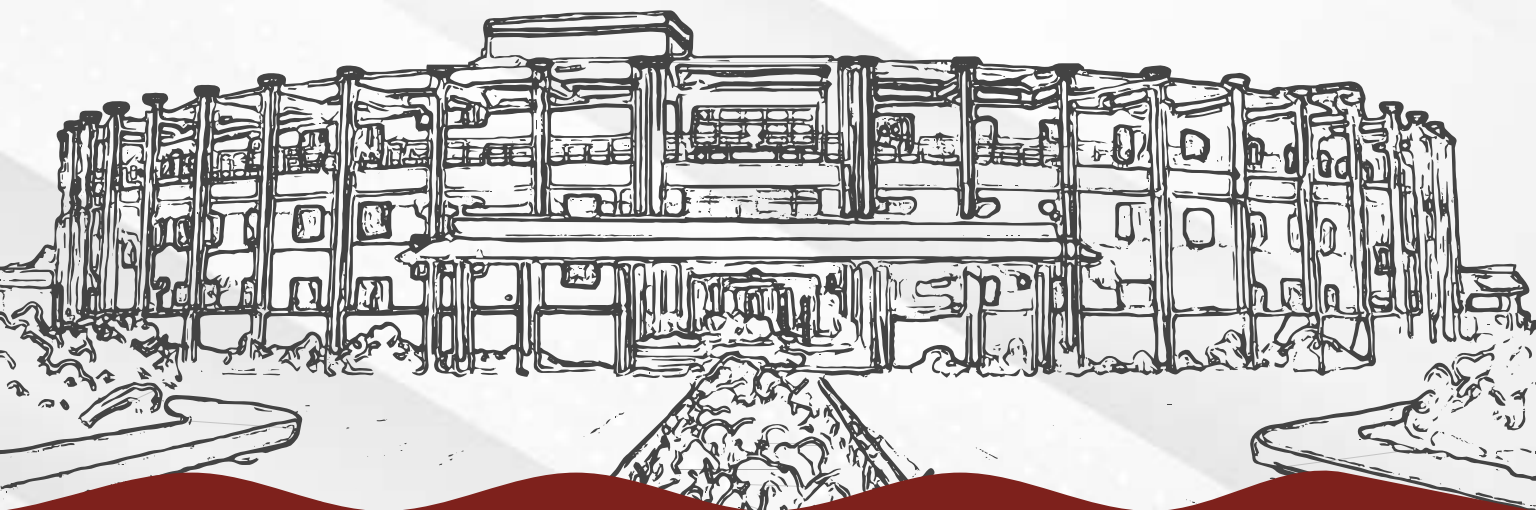
