- Abstract shall not exceed 250 words.
- Abstract should contain Title of the paper, Authors details as footnotes
- The submissions will be adjudged and selected purely on the basis of merit and originality.
- Intimation of the acceptance of the abstract will be done after the submission of the same, thereafter the participant can proceed with submission of full paper and registration process.
- The selected papers, completed in every manner as informed below, should be sent to the link shared to the selected papers by 02/09/2026
- The last date of Payment and registration for the conference as a presenter or participant is on 02/09/2026
- Each submission should include the following:
 - 1.Word Limit- 3000-5000 Words (including footnotes)
 2. Font-Times New Roman,

The submission should be original and not simultaneously considered by any other seminar, conference, journal, chapter in a book, etc.
