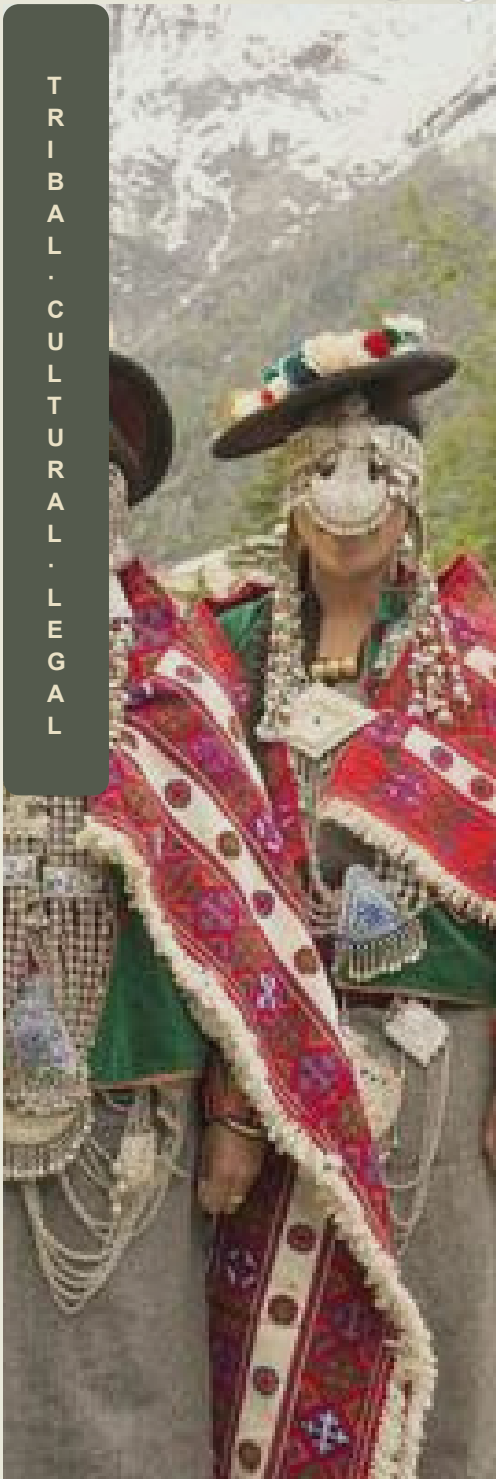
## About HPNLU

- 03 **Tribal Autonomy and Self-Governance: Reimagining the Fifth and Sixth Schedules in Contemporary India**

## AUTHORSHIP

Participation may be individual or in co-authorship with up to two authors. Each participant/team may submit only one article.

## ORIGINALITY

The article must be original, unpublished, and not under consideration elsewhere.

## WORD LIMIT

1200–1500 words, excluding footnotes, title, and bibliography.

02.

## Formatting

- Font: Times New Roman, 12-point
- Headings: 14-point, bold
- Footnotes: Times New Roman, 10-point
- Line Spacing: 1.5
- Footnotes: Single spacing
- Alignment: Justified
- Margins: 1 inch on all sides
- Paper Size: A4
- File Format: Microsoft Word (.doc/.docx)

## PLAGIARISM

Articles with a similarity index above 10% may be rejected.

04.

## CERTIFICATES

Every participant will be given a “Certificate of Participation”, provided that the registration fees have been paid.

## AI- REPORT

AI-generated content must not exceed 20% of the submission.

06.

## CITATION STYLE

Footnotes must follow Chicago citation style.

07.

## ANONYMITY

The Article must not contain the author(s) name, institutional affiliation, contact details, institutional logo, acknowledgements, or any other information that may reveal their identity.

08.

## DISQUALIFICATION

Non-compliance with the prescribed word limit, formatting, citation, originality, anonymity, or submission requirements may result in rejection or disqualification.

## EVALUATION

Articles shall be evaluated on the basis of:

- Originality, Quality of Research
- Depth of Analysis and Logical Reasoning
- Engagement with Contemporary Developments
- Clarity, Structure and Coherence
- Language and Presentation
- Referencing and Citations

## ORGANISING COMMITTEE

- The organising committee reserves the right to interpret, modify, or enforce these guidelines.
- In case of any dispute or ambiguity, the decision of CTCS, HPNLU and the organising committee shall be final and binding.
- Submission of an article shall be deemed to constitute acceptance of these guidelines.

- Single Authorship: ₹350
- Co-Authorship (Maximum of Two Authors): ₹500
